WARRANTY DEED

HELENS PULP AND PAPER COMPANY, a corporation, receipt whereof is hereby acknowledged, conveys and warrants to said St. Helens Pulp and Paper Company, a corporation, its successors and assigns, the following described real estate situate in the County of Skamania, State of Washington, to-wit:

The southeast quarter (SE $^{\frac{1}{2}}$ ) in Section 3, Township 2 North, Range 5 East of the Willamette Meridian,

EXCEPTING, however, all minerals, mineral oils and gas in place, discovered or which may hereafter be discovered upon said premises or within the same, together with the right of ingress and egress for the purpose of prospecting for said minerals, mineral oils and gas, and developing and operating mines for the removal thereof; the right to sink shafts and develop any mine or prosecute any mining operations which may be necessary for the discovery or removal of the said minerals from the surface or from beneath the surface of said property.
