CORRECTION DEED

The Grantors, WALTER FRITTS and EMMA FRITTS, husband and wife, for and in consideration of the sum of \$1.00 and other good and sufficient consideration to them paid, receipt whereof is hereby acknowledged, convey and warrant to LOUIS L. HALL and MARION S. HALL, husband and wife, the following described real property situated in Skamania County, State of Washington, to-wit:

The West half of the Southwest quarter of the Southwest quarter (W $\frac{1}{2}$  of SW $\frac{1}{4}$  of SW $\frac{1}{4}$  of Section Eight (8), Township One (1) North of Range Five (5), East of the Willamette Meridian;

And: The East half of the Southeast quarter (E $\frac{1}{2}$  of SE $\frac{1}{4}$ ) and the Southwest quarter of the Southeast quarter (SW $\frac{1}{4}$  of SE $\frac{1}{4}$ ), of Section Seven (7) Township One (1) North of Range Five (5) East of the Willamette Meridian;

EXCEPT THAT PORTION THEREOF DESCRIBED AS FOLLOWS:

Commencing at the Southeast corner of said Section Seven (7), thence North along the East section line 18 rods; thence west 92 rods more or less to a point on the East brink of the Canyon thereon; thence South along the East brink of said South Section line to the point of beginning.

SUBJECT to the agreement with B. Jemtegaard to use a strip on the south side of the tract for road purposes, and certain water rights as recorded in Book "p" of Deeds at page 80, records of Skamania County, Washington.
