Beginning at the intersection of the southwesterly limit of the B. B. Bishop Donation Land Claim Number 39 in Sections 20 and 21, Township 2 North, Range 7 East of the Willamette Meridian with the meander line on the north bank of the Columbia River; thence along the southwesterly limit of the B. B. Bishop Donation Land Claim 969.91 feet to the intersection of said limit with the southerly line of that certain tract of land described in Parcel "A" in that certain deed from Frank M. Warren and wife, George A.
