- 6. This agreement and rights and benefits conferred upon each party shall be and remain in force and binding upon and enforceable by the heirs, executors, administrators, assigns and successors of all parties hereto whatsoever.
- 7. No member of or delegate to Congress, or Resident Commissioner, shall be admitted to any share in this contract or to any benefit to arise therefrom unless it be made with a corporation for its general benefit.

DESCRIPTION

Fract (10a)

Township Three (3) North, Range Nine (9) East, Willamette Meridian:
In section twenty-six (26), that part of lot four (4) bounded and described as follows: Beginning at Corner 1, a point in the line common to lots four (4) and five (5), said point being S.22°44'E., 22.25 chains from the one quarter corner common to sections twenty-six (26) and twenty-seven (27), and monumented by a concrete post; thence N.1°27'E passing within lot four (4), 5.62 chains to Corner 2, a point in the south of way boundary of the Old Indian Road, so called, and monumented by a concrete post; thence southeasterly with the south right-of-way boundary of the said Old Indian Road, with the meanders thereof, 5.48 chains to Corner 3, monumented by a concrete post; thence S.12°20'E., 3.43 chains to Corner 4, a point in the line common to aforesaid lots four (4) and five (5), and monumented by a concrete post; thence N.87°44'W., with the line common to the aforesaid lots four (4) and five (5), 5.55 chains to the Place of BEGINNING; and containing 2.43 acres, be the same more or less.
