WARRANTY DEED

Beginning at the northwest corner of Section 35, Township 3 North, Range 8 E.W.M.; thence south 89°00' east on the north line of the said Section 35, 190.75 feet; thence south 577.3 feet to the northerly right of way line of State Highway No. 8; thence south 64°39' east along the said right of way line 642.9 feet to the initial point of the tract hereby described, said point being 83.0 feet north 64°39' west of the intersection of the said right of way line with the northerly right of way line of a county road; thence south 64°39' east 83.0 feet to the said intersection; thence south 75° 23' east 82.6 feet along the northerly right of way line of the said county road; thence north 595.9 feet to the intersection with the southerly line of a tract of land conveyed to the Spokane, Portland and Seattle Railway Company for a gravel pit by deed dated February 13, 1908, and recorded on February 17, 1908, at page 28 of Book L of Deeds, Records of Skamania County, Washington, as corrected by deed dated April 1, 1909, and recorded June 18, 1909, at page 460 of Book L of Deeds; thence north 56°00' west along said southerly line 173.6 feet; thence south 636.6 feet to the point of beginning, containing 2.2 acres.
