BAR-X SUPPLY LATERAL PIPE LINE

Bar-X Supply Lateral Pipe Line approximately 6 miles in length, beginning in Section 21, T-9-S, R-104-W, Mesa County, Colorado, and ending in Section 17, T-17-S, R-26-E, Grand County, Utah, and more particularly described as follows:

BEGINNING at a point in Section 21, T-9-S, R-104-W, Mesa County, Colorado.

THENCE, running in a northwesterly direction approximately 5.5 miles to a point of exit from said county in Section 36, T-8-S, R-105-W.

THENCE, entering Grand County, Utah, at a point in Section 21, T-17-S, R-26-E, continuing across said county in a northwesterly direction a distance of approximately .5 miles to a point of termination in said county in Section 17, T-17-S, R-26-E.

There being also certain lateral and well lines connected to the aforementioned Bar-X Supply Lateral Pipe Line, consisting of lines connecting producing gas wells in T-8-S, R-104-W, Mesa
