ORDER APPROVING FINAL REPORT
AND
DECREE OF DISTRIBUTION

This matter coming on regularly to be heard on the 9th day of April, 1951 upon the Final Report and Petition for Distribution of Patrick C. Hogan, the duly appointed, qualified, and acting administrator with the Will annexed of the Estate of Kenneth M. Grasseeth, deceased, and of the Partnership Estate of Kenneth M. Grasseeth, deceased, and Patrick C. Hogan, and it appearing to the satisfaction of the Court that Notice of the Hearing on said Report on this date was duly advertised and posted as required by law and that said Administrator with the Will Annexed and Nina Mae Grasseeth, the sole devisee and legatee, under the last Will and Testament of the above named deceased admitted to probate herein and Jerome Walstead, the duly appointed, qualified and acting Guardian Ad Litem of all of the minor children of said deceased, to-wit:

all of Longview, Wn., each appeared in person in Court at the hearing on said petition and report and the Court having heard the testimony in support of said report and it appearing to the Court that in said Final Report the cost of Publication of Notice of Hearing on the same was estimated at \$12 and the actual charge therefor was \$9.30, and that said Final Report of the said Patrick C. Hogan is in all other particulars true and correct, and, being fully advised in the premises:

It is, therefore, ORDERED, ADJUDGED and DECREED that said Final Report and Petition for Distribution of said Patrick C. Hogan, Administrator with the Will Annexed, and all of his acts and all expenses incurred and payments made by him as set forth in said Report relating to said Estate be, and the same are hereby, fully ratified, approved and confirmed.

It is further ORDERED, ADJUDGED, and DECREED that the sum of \$760.00 is a reasonable fee to allow said Administrator with the Will Annexed for his services herein; that the sum of \$760.00 is a reasonable charge to allow his attorneys, Imus & Marsh, for their services herein; that the sum of \$35.00 is a reasonable sum to allow Jerome Walstead, the Guardian Ad Litem herein, as his fee therefor, and the said Patrick C. Hogan as such Administrator with the Will Annexed, is hereby authorized and directed to pay said sums out of said Estate, together with the claims filed herein as set forth in said Final Report.

It is further ORDERED, ADJUDGED, and DECREED that the following are the only heirs at law of said decedent, to-wit:

Kenneth M. Grasseeth, Jr., a minor,
Joel Marie Anna Grasseeth, a minor,
Douglass O. Grasseeth, a minor,

all of Longview, Wn., the last named three heirs being the only children of said deceased.

That under said Last Will and Testament of said Decedent admitted to probate herein, the said Nina Mae Grasseeth is the sole devisee and legatee and it is hereby Ordered that the following property be, and it hereby is, awarded and set over to the said Nina Mae Grasseeth as her sole and separate property, to-wit:
