CONFIRMATION FLOWAGE EASEMENT

THIS INDENTURE, made this 10th day of May, 1951, by and between Emma Hill Yoe and Warren W. Yoe, her husband, and who was her husband on August 19, 1932, hereinafter called the Grantors, and the United States of America, hereinafter called the Government, witness eth:

THAT WHEREAS, the Government is constructing a dam across the Columbia River between the States of Oregon and Washington at Bonneville, Oregon, and upon the completion of said dam will operate and maintain a spillway, power house and ship lock; and

WHEREAS, in constructingsaid structures, the Government will increase periodically the depth and duration of the overflow on the lands hereinafter described lying above elevation 72.0 feet; and

WHEREAS, the Government has purchased a flowage easement from Skamania County under date of September 7, 1938; and

WHEREAS, by deed in favor of the said Emma Hill Yoe bearing date of August 19, 1932 and recorded in Book "X" of Deed Records of Skamania County, Washington, at page 491, the hereinafter described lands belonging to Skamania County were by error included therein, and the Government being desirous of having its title to flowage easement aforesaid confirmed by the Grantors herein;

NOW THEREFORE, the Grantors, for and in consideration of the premises and for the purpose of confirming said flowage easement and of the sum of One Dollar (\$1.00), cash in hand paid by the Government, the receipt whereof being hereby acknowledged, do hereby remise, release and quitclaim unto the Government or its assigns, forever, the full and perpetual right, power, privilege and easement to overflow all of the following described real property, to-wit:

All that portion of Lotl, Section 32, Township 3 North, Range 8 East of the Willamette Meridian, in Skamania County, Washington, bounded and described as follows, to-wit:

Beginning at a point 20 chains east of the corner of Sections 29, 30, 31 and 32 of Township 3 North, Range 8 East of the Willamette Meridian; thence East on a true line 8 chains and 50 links; thence South to the meander line of the Columbia River; thence in a westerly direction with the said meander line of said Columbia River to a point directly south of said point of beginning; thence north to the place of beginning.

TO HAVE AND TO HOLD unto the Government or its assigns, forever, together with the right to go upon the lands above described from time to time as the occasion may require and remove therefrom the timber and other natural growth, and any accumulations of brush, trash or driftwood;

And the Grantors aforesaid, in consideration of the above specified sum, also hereby release the Government from all claims for damages that have accrued or may hereafter
