EASEMENT FOR DRAINAGE DITCH

KNOW ALL MEN BY THESE PRESENTS, that

IN THE MATTER OF Primary State Highway No. 8, North Bonneville Vicinity

Fred T. Ellis and Anna Ellis, husband and wife, and Ella June Kelly also known as Ella J. Kelly, a single person

for and in consideration of the sum of Five (\$5.00) Dollars, in hand paid, the receipt whereof is hereby acknowledged, do hereby grant and warrant unto the STATE OF WASHINGTON, the perpetual right, permit, license and easement to use and occupy the hereinafter described lands for the purposes of constructing and maintaining drainage areas and drainage ditches, said lands being situated in SKAMANIA County, State of Washington, and described as follows, to-wit:

A strip of land 20 feet wide, being a portion of a tract of land to be hereinafter described, said strip of land being 10 feet wide on the Westerly side and 10 feet wide on the Easterly side of a center line described as follows: Beginning at a point on the center line survey of said highway at Highway Engineer's Station P.T. 187/43; thence North 75° 34' East, a distance of 123.2 feet to a point on the semitangent of said highway; thence North 9° 43' West a distance of 20 feet to a point and the initial point of this description; thence North 9° 43' West a distance of 80 feet to a point and the end of this center line description; EXCEPTING therefrom all that portion of said strip of land which has been heretofore conveyed to Skamania County or the State of Washington, for public road or highway purposes.
