All bridges, roads and other structures and improvement placed upon said lands by said Grantee, save and except such improvements as by their nature are designed to be movable, shall be deemed to be fixtures and a part of said lands and shall become the property of said Grantors upon the termination of the rights of the Grantee hereunder.
- 7. In the event said Grantee shall violate any of the covenants and agreements hereinabove set out and shall fail to cure such violation within thirty days after demand
  therefor by said Grantors, all of the rights and privileges hereby granted to said Grantee
  shall automatically be suspended without further notice or proceeding until such violation
  shall have been cured, but without prejudice to the right, if any, of said Grantors to recover from Grantee any damages for such violation or to pursue any other remedy or remedies
  which said Grantors may have therefor.
