situated in the County of Skamania State of Washington:—

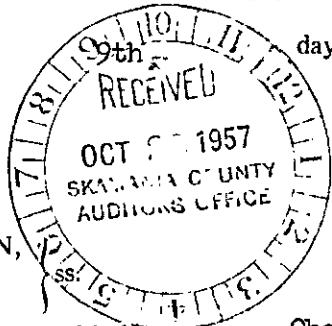
The Southeast Quarter of the Northeast Quarter and the Northeast Quarter
