AALVIK, a single man, Stevenson, Washington the following described real estate, situate in the county of Skamania state of Washington:

Beginning at a point describing the intersection between the division line of the Henry Shepard D.L.C. and the center line of Strawberry Road, said point being on the south line of Stevenson Park Addition according to the official plat thereof and being 1665.9 feet east of the west line of the said Shepard D.L.C.; thence southerly along the center of the said Strawberry Road a distance of 155 feet to the initial point of the tract hereby described; thence southerly along the center of the said road a distance of 16 feet; thence south 64° 06' west a distance of 150 feet; thence south 27° 02' east a distance of 165 feet; thence south 52° 56' west 160 feet to the center of Kanaka Creek; thence northerly following the center of the said creek to a point which is south 64° 06' west and 285 feet distant from the initial point; thence north 64° 06' east 285 feet to the initial point.
