IT IS FURTHER ORDERED, ADJUDGED AND DECREED that the title to the household furnishings and livestock located thereon shall be vested in the plaintiff as her own and sole property, free and clear of any lien, right, claim, equity or interest of the defendant.

IT IS FURTHER ORDERED, ADJUDGED AND DECREED that the real property located in Skamania County, Washington, and the real property located in Multnomah County, Oregon including the Nyleta Court Apartments, both real and personal, and the Sacramento Street property be and the same is hereby decreed to be the sole and exclusive property of the defendant.

IT IS FURTHER ORDERED, ADJUDGED AND DECREED that each of the parties shall forthwith execute proper legal documents to vest said title in the respective parties pursuant to the terms of this decree, and in the event either of said parties fails to execute said documents, this decree shall stand as for a deed and shall by decree of Court vest the title to the respective properties in the name of the respective owners as shown by the terms of this decree.

IT IS FURTHER ORDERED, ADJUDGED AND DECREED that neither party shall recover costs and disbursements, and it is
