BORROW PERMIT LEASE

IN THE MATTER OF Primary State Highway No. 8, Cape Horn to Skamania.

(PIT SITE NO. SA-29)

KNOW ALL MEN BY THESE PRESENTS, that Robert C. Prindle and Louise A. Prindle, husband and wife of. Prindle, Washington for and in consideration of the sum of Five Cents per yard (5¢) Pit run, in hand paid, the receipt whereof is hereby acknowledged, do hereby grant and warrant unto the STATE OF WASHINGTON, the right, permit, license and lease to use and occupy the hereinafter described lands at any and all times from date hereof until June 1, 1954, 19___, for the purpose of excavating and removing highway materials in any quantity, consisting of rock, gravel, sand and/or earth from any portion of said lands, storing and stockpiling crushed rock or other highway materials thereon, and operating all necessary machinery and equipment thereon, said lands being situated in Skamania County, State of Washington and described as follows, to-wit:

A tract of land containing 4.50 acres, more or less, and more fully described as follows; Commencing at the Southeast corner of Section 2, Township 1 North, Range 5 East, W.M., thence North 6° 29' 30" West a distance of 213.2 feet, to the true point of beginning; thence South 57° 50' 30" West a distance of 251.8 feet; thence North 24° 40' 30" West a distance of 392.0 feet; thence North 63° 34' East a distance 540.5 feet; thence South 32° 17' East a distance of 299.6 feet; thence South 52° 33' West a distance of 356.7 feet to the true point of beginning.
