THIS AGREEMENT made and entered into between John McGillivary and Dorothy McGillivary, husband and wife, hereinafter referred to as the first parties, and Gus Bloomquist, John Bloomquist and Axel Bloomquist, doing business as Bloomquist Logging Company, hereinafter referred to as second party.

WITNESSETH:

That for and in consideration of the sum of Three Hundred Fifty (\$350.00) Dollars the parties of the first party hereby grant to the party of the second part a right of way for road purposes for the hauling of logs and timber and as an access road through the property owned by first parties. This right of way crosses over Section thirty-two (32) and the west half of Section 33, Township 3 North, Range 5 East of the Willamette Meridian.

The second party shall have the right to grade and improve the road and also the first parties shall have the right to use the road for their own purposes.

The location of the right of way is to be selected by the second party.
