LEASE AND PERMIT TO STOCKPILE ROAD MATERIALS

IN THE MATTER OF Primary State Highway No. 8- Stevenson to Underwood

KNOW ALL MEN BY THESE PRESENTS, that James A. Zieser and Viola Zieser husband and wife of San Pedro, California for and in consideration of the sum of TWO HUNDRED (\$200.00) Dollars, in hand paid, the receipt whereof is hereby acknowledged, do hereby grant and warrant unto the STATE OF WASHINGTON, the right, permit and lease to use and occupy exclusively the hereinafter described lands for the purpose of depositing, storing and stockpiling crushed stone and other highway materials thereon at any and all times from date hereof until July 1, 1951 19, said lands being situated in Skamania County, State of Washington, and described as follows, to-wit:

A tract of land containing 0.55 acres, more or less, situated in the Southwest Quarter of the Southwest Quarter (SW $\frac{1}{4}$ of SW $\frac{1}{4}$), of Section 36, Township 3 North, Range 7 $\frac{1}{2}$ East, W.M., lying and being Northerly of Primary State Highway No. 8, Stevenson to Underwood, being all that portion lying Southerly of a line drawn parallel with and 200 feet distant Northerly when measured at right angles and/or radially from the center line survey of said highway, extending from the center of Kanaka Creek, Easterly, to a line projected Northerly at right angles and or radially at Highway Engineers Station 59+00. EXCEPTING therefrom all that portion of the said tract of land that may have been heretofore conveyed for roads and/or highway purposes.
