TIMBER DEED

THIS INDENTURE, made and entered into this 29th day of November, 1951, between O. C. LARSEN and ROSE H. LARSEN, husband and wife, Grantors, and MC CORMICK LUMBER & MFG. CORPORATION, a corporation existing under and by virtue of the laws of the State of Washington, Grantees,

WITNESSETH:

That the Grantors, for and in consideration of the sum of One Thousand Dollars (\$1000.00) to them in hand paid, the receipt whereof is hereby acknowledged, do hereby grant, bargain, sell and convey unto Grantee its heirs, executors, administrators and assigns, all the merchantable timber lying, standing or being upon all that tract of land in the County of Skamania and State of Washington, to-wit:

S $\frac{1}{2}$ SW $\frac{1}{4}$ SE $\frac{1}{4}$ of Section 16, Twp. 3 North, Range 10, EWM, together with the right to enter upon said land and cut and remove therefrom at any time within one(1) year from the date hereof the timber herein conveyed, and to cut such other timber and make such other alterations on said lands as may be required in the cutting and removal of said timber.

TO HAVE AND TO HOLD, the said merchantable timber, to the said Grantee, its heirs, executors, administrators and assigns, forever, together with the exclusive right of occupancy of said lands, for and during the term aforesaid.

And the above described lands, premises and property, in the quiet peaceable and exclusive possession of Grantee, its heirs, executors, administrators and assigns against all persons lawfully claiming or to claim the whole or any part thereof, Grantors will warrant and defend.
