TIMBER DEED.

The Grantors, Frank Birkenfeld and Ruth Birkenfeld, husband and wife, in consideration of the sum of \$100.00, in hand paid, convey and quit claim to C. R. Yunker, F. C. Dillard, and H. H. Wieck, doing business as Yunker Logging co Wheeler, Oregon all of the timber 16" and Over in diameter, at the butt on the following described lands located in Skamania County, Washington:

The Southwest quarter of the Northeast quarter and the North east quarter of the Southeast quarter of Section 21, Township 3 North, Range 8 East of the Willamette Meridian. East of Wind River only.

The grantees herein shall have a period of 5 years after the 18th day of October, 1948, within which to remove the timber. They will use due care and caution in removing the same so as to cause as little damage to the timber still standing as possible under the circumstances.

They are to have the right of ingress and egress into and upon the lands for the purpose of removing the said timber, also the successors and assigns of the grantees herein. All rights and privileges granted the grantees herein shall extend to and apply to
