PARCEL # I

The Northeast Quarter of the Northeast Quarter (NE $\frac{1}{4}$ NE $\frac{1}{4}$) of Section 10,
Township 1 North, Range 5 East of the Willamette Meridian;

ALSO: All that portion of the Northeast Quarter of the Southeast Quarter
of the Northeast Quarter (NE $\frac{1}{4}$ SE $\frac{1}{4}$ NE $\frac{1}{4}$) of Section 10, Township 1 North, Range
5 East of the Willamette Meridian, lying northerly of State Highway No. 8.

PARCEL # 2

The Southwest Quarter (SW $\frac{1}{4}$), and the Southwest Quarter of the Northwest
Quarter (SW $\frac{1}{4}$ NW $\frac{1}{4}$) EXCEPT that portion thereof consisting of 7 $\frac{1}{2}$ acres, more or less,
conveyed to Mansuetto Tavelli by deed dated January 14, 1908, recorded at
page 14 of Book L of Deeds, records of Skamania County, Washington; all in
Section 2, Township 1 North, Range 5 East of the Willamette Meridian;

ALSO: The East Half of the Southeast Quarter (E $\frac{1}{2}$ SE $\frac{1}{4}$) of Section 3, Township 1
North, Range 5 East of the Willamette Meridian;

ALSO: An undivided one-half interest in and to a certain spring and all water
flowing therefrom located in the southeast corner of the Northwest Quarter of
the Northwest Quarter (NW $\frac{1}{4}$ NW $\frac{1}{4}$) of the said Section 2 together with an
easement for a water pipeline from said spring as reserved by James H. Miller
