Station 690/68.42; thence northerly 160.0 feet along the arc of a 1.6 degree spiral curve to the left to S.T. Station 692/28.42; thence north 6 degrees 42 minutes west 1297.33 feet to T.S. Station 705/25.75; thence northerly 160.0 feet along the arc of a 2.8 degree spiral curve to the right to S. C. Station 706/85.75; thence northerly 950.95 feet along the arc of a 3 degree 30 minute curve to the right to C.S. Station 716/36.70; thence northerly 51.0 feet along the arc of a 2.8 degree spiral curve to the right to Station 716/87.7 and a point on the north line of the $E\frac{1}{2}SW\frac{1}{4}$ said Section 10, being distant south 88 degrees 19 minutes west 329.20 feet from the center quarter corner of said Section 10; thence from Station 716/87.7 northerly 109.0 feet along the arc of said 2.8 degree spiral curve to the right to S. T. Station 717/96.70; thence north 32 degrees 11 minutes east 503.1 feet to Station 722/99.8 and a point on the easterly line of the $SE\frac{1}{4}NW\frac{1}{4}$, Section 10, said point being distant north 0 degrees 26 minutes west 508.4 feet from the southeast corner of said $SE\frac{1}{4}NW\frac{1}{4}$, Section 10, containing 40.082 acres.

Beginning at Station 438/01.5 of said center line and a point on the south line of $SW\frac{1}{4}NE\frac{1}{4}$, Section 3 and distant due east, 311.0 feet from the southwest corner of said $SW\frac{1}{4}NE\frac{1}{4}$; thence northwesterly from the point of beginning, also a point on the arc of 2 degree 00 minute curve to the left, 177.7 feet to C.S. Station 439/79.2; thence northwesterly, 160.0 feet along the arc of a 1.6 degree spiral curve to the left to S.T. Station 441/39.2; thence north 33 degrees 11 minutes west, 1215.3 feet to Station 453/54.5 and a point on the north line of the $SE\frac{1}{4}NW\frac{1}{4}$ of said Section 3, and distant south 89 degrees 42 minutes west, 545.2 feet from the northeast corner of said $SE\frac{1}{4}NW\frac{1}{4}$, Section 3, and

Beginning again at Station 467/27.3 of said center line and a point on the east line of Lot 4 of said Section 3 distant south 0 degrees 47 minutes west, 160.7 feet from the northeast corner of said Lot 4; thence north 33 degrees 13 minutes west, 186.0 feet to Station 469/13.3 and a point on the north line of said Section 3, distant south 89 degrees 27 minutes west, 99.8 feet from the northeast corner of said Lot 4, containing 7.98 acres.
