

therefrom, when measured at right angles and/or radially from said center line and from Highway Engineer's Station 541/00 easterly to Highway Engineer's Station 547/00 said strip of land shall include all that portion of said subdivision northerly of existing Secondary State Highway No. 1-S lying within a strip of land 290 feet in width being 140 feet wide on the northerly side and 150 feet wide on the southerly side of said center line, and from Highway Engineer's Station 547/00 easterly to Highway Engineer's Station 548/00 said strip shall be 215 feet in width being 140 feet wide on the northerly side and 75 feet wide on the southerly side of said center line, and from Highway Engineer's Station 548/00 easterly to Highway Engineer's Station 554/00 said strip shall be 150 feet in width being 75 feet wide on each side of said center line, EXCEPT any portion which may have been conveyed for public roads.

- (f) 2. A tract of land in Cowlitz County, Washington, described as follows:

All that portion of a strip of land 100 feet in width, being 50 feet wide on each side of the center line of Secondary State Highway No. 1-S, Ariel to Rock Creek, lying within the Northwest quarter of the Southeast quarter, the Southwest quarter of the Southwest quarter, the Northeast quarter of the Southwest quarter, the Southwest quarter of the Northeast quarter, and Government Lot 7 all in Section 27, the Southeast quarter of the Northeast quarter and Government Lot 1 all in Section 33, Government Lots 3, 4 and 5 in Section 34, all in Township 6 North, Range 2 East, W.M., the Southwest quarter of the Southeast quarter of Section 18, the Northeast quarter of the Northeast quarter of Section 19, and the Northwest quarter of the Northwest quarter of Section 20, in Township 6 North, Range 3 East, W.M., EXCEPT that from Highway Engineer's Station 557/00 (all Highway Engineer's Stations to be hereinafter referred to as HES) Northeasterly to HES 562/00 said strip shall be 125 feet in width, being 50 feet wide on the Southeasterly side and 75 feet wide on the Northwesterly side of said center line, AND EXCEPT that from HES 562/50 Northeasterly to HES 565/00 said strip shall be 110 feet in width, being 60 feet wide on the Southeasterly side and 50 feet wide on the Northwesterly side of said center line, AND EXCEPT that from HES 569/50 Northeasterly to HES 571/50 said strip shall be 130 feet in width, being 50 feet wide on the Southeasterly side and 80 feet wide on the Northwesterly side of said center line, AND EXCEPT that from HES 573/50 Northeasterly to HES 577/99.2 said strip shall be 190 feet in width, being 140 feet wide on the Southeasterly side and 50 feet wide on the Northwesterly side of said center line, AND EXCEPT that from HES 577/99.2 easterly to HES 578/04.2 said strip shall be 140 feet in width being 90 feet wide on the South side and 50 feet wide on the North side of said center line, AND EXCEPT that from
