said center line, AND EXCEPT that from HES 642/00 Northeasterly to HES 647/00 said strip shall be 110 feet in width, being 60 feet wide on the Southeasterly side and 50 feet wide on the Northwesterly side of said center line, AND EXCEPT that from HES 845/00 Easterly to HES 847/00 said strip shall be 150 feet in width, being 100 feet wide on the Southerly side and 50 feet wide on the Northerly side of said center line, AND EXCEPT that from HES 850/00 Easterly to HES 853/00 said strip shall be 110 feet in width, being 60 feet wide on the Southerly side and 50 feet wide on the Northerly side of said center line, AND EXCEPT that from HES 853/00 Easterly to HES 856/00 said strip shall be 130 feet in width, being 80 feet wide on the Southerly side and 50 feet wide on the Northerly side of said center line, AND EXCEPT that from HES 856/00 easterly to HES 862/50 said strip shall be 140 feet in width, being 90 feet wide on the Southerly side and 50 feet wide on the Northerly side of said center line, AND EXCEPT that from HES 864/50 Easterly to HES 867/00 said strip shall be 120 feet in width, being 70 feet wide on the Southerly side and 50 feet wide on the Northerly side of said center line, AND EXCEPT that from HES 871/00 Easterly to HES 876/50 said strip shall be 140 feet in width, being 90 feet wide on the Southerly side and 50 feet wide on the Northerly side of said center line, AND EXCEPT that from HES 876/50 Easterly to HES 878/50 said strip shall be 160 feet in width, being 90 feet wide on the Southerly side and 70 feet wide on the Northerly side of said center line, AND EXCEPT that from HES 878/50 Easterly to HES 880/50 said strip shall be 140 feet in width, being 90 feet wide on the Southerly side and 50 feet wide on the Northerly side of said center line, AND EXCEPT that from HES 880/50 Easterly to HES 881/50 said strip shall be 150 feet in width, being 100 feet wide on the Southerly side and 50 feet wide on the Northerly side of said center line, AND EXCEPT any portion thereof conveyed for public road purposes.

(f) 3. A tract of land in Cowlitz County, Washington, described as follows:

All that portion of the following described Parcel "A" lying within a strip of land having widths as hereinafter set forth on each side of the center line of Secondary State Highway No. 1-S, Rock Creek to Yale.

From Highway Engineer's Station 903/94 (all Highway Engineer's Stations hereinafter referred to as "Station") easterly to Station 909/00, said strip shall be 100 feet in width being 50 feet wide on each side of said center line; and from Station 909/00 easterly to Station 912/50 said strip shall be 150 feet in width being 100 feet wide on the southerly side and 50 feet wide on the northerly side of said center line; and from Station 912/50 southeasterly to Station 920/00 said strip
