

of existing Secondary State Highway No. 1-S and easterly of a line drawn parallel with and 70 feet westerly when measured at right angles and/or radially from said center line; and from Station 1010/00 southeasterly to Station 1014/00 said strip shall be 160 feet in width being 70 feet wide on the southwesterly side and 90 feet wide on the northeasterly side of said center line; and from Station 1014/00 easterly to Station 1015/00 said strip shall be 210 feet in width being 120 feet wide on the southerly side and 90 feet wide on the northerly side of said center line; and from Station 1015/00 easterly to Station 1017/00 said strip shall include all that portion of said Parcel "A" lying southerly of the existing Secondary State Highway No. 1-S and northerly of a line drawn parallel with and 120 feet southerly when measured at right angles and/or radially from said center line; and from Station 1017/00 northeasterly to Station 1017/50 said strip shall include all that portion of said Parcel "A" lying southeasterly of existing Secondary State Highway No. 1-S and northwesterly of a line drawn parallel with and 70 feet southeasterly when measured at right angles and/or radially from said center line; and from Station 1017/50 northeasterly to Station 1019/00 said strip shall be 130 feet in width being 70 feet wide on the southeasterly side and 60 feet in width on the northwesterly side of said center line; and from Station 1019/00 northeasterly to Station 1042/00 said strip shall be of varying width extending on the northwesterly side of the existing Secondary State Highway No. 1-S to a line drawn parallel with and measured at right angles and/or radially from said center line and described as follows:

From Station 1019/00 northeasterly to Station 1023/00 said line shall be 60 feet northwesterly, from Station 1023/00 northeasterly to Station 1026/50 said line shall be 100 feet northwesterly, from Station 1026/50 northeasterly to Station 1029/50 said line shall be 140 feet northwesterly, from Station 1029/50 northeasterly to Station 1042/50 said line shall be 70 feet northwesterly and the end of this line description.

ALSO from Station 1042/50 northeasterly to Station 1044/00 said strip shall be 190 feet in width being 120 feet wide on the southeasterly side and 70 feet wide on the northwesterly side of said center line; and from Station 1044/00 northeasterly to Station 1050/00 said strip shall be 210 feet in width being 120 feet wide on the southeasterly side and 90 feet wide on the northwesterly side of said center line; and from Station 1050/00 northeasterly to Station 1052/50 said strip shall be 180 feet in width being 120 feet wide on the southeasterly side and 60 feet wide on the northwesterly side of said center line; and from Station 1052/50 northeasterly to Station 1062/50 said strip shall be 120 feet in width being 60 feet wide on each side of
