QUIT CLAIM DEED

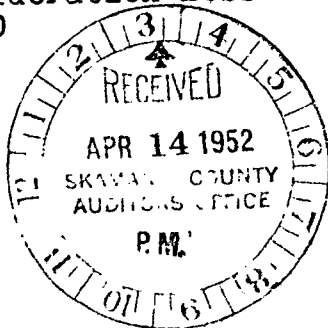

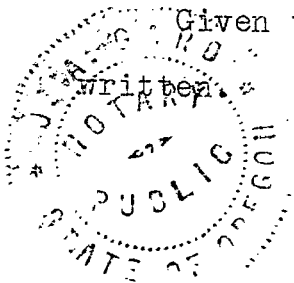

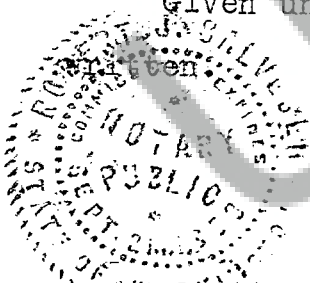
