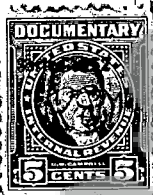
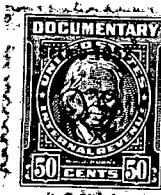
QUITCLAIM DEED
