EXECUTRIX'S DEED

Lot 5, Block 2, Townsite of Cook according to the official plat thereof on file and of record in the office of the Auditor of Skamania County, Washington.

TOGETHER with the tenements, hereditements, and appurtenances whatsoever to the same belonging or in anywise appertaining;

TO HAVE AND TO HOLD, all and singular, the above-mentioned and described premises, together with the appurtenances, unto the said party of the second part;
