TIMBER DEED

KNOW ALL MEN BY THESE PRESENTS that HILDA L. SHARP, a single woman, in consideration of Ten Dollars (\$10.00) and other valuable considerations to her paid by SHEPARD & MORSE LUMBER COMPANY, a Maine corporation, does hereby grant, bargain, sell and convey unto Shepard & Morse Lumber Company, its successors and assigns, all of the timber measuring 16 inches or more in diameter breast high inside the bark standing, lying or being on the following described real property in the County of Skamania, State of Washington:

Block 18 of Manzanola Tracts according to the official plat thereof on file and of record in the office of the Auditor of Skamania County, Washington; said property being also described as the southeast quarter of the northwest quarter of Section 15, Township 3 North, Range 9 E. W. M.; and containing 40 acres more or less.

with the right to enter upon said land for a period of time terminating on December 31, 1953, and cut, log and remove the said timber with all rights, easements and privileges in and upon said land necessary for such cutting, logging and removal.

TO HAVE AND TO HOLD the above-described timber and rights unto the said Shepard & Morse Lumber Company, its successors and assigns; provided that the above-described timber shall be cut and removed by December 31, 1953, and all rights of Shepard & Morse Lumber Company hereunder shall automatically cease and determine at the expiration of said period.

The grantor hereby covenants with Shepard & Morse Lumber Company, its successors and assigns, that she is the lawful owner of the above-described premises and of the timber thereon, that the same are free from all encumbrances, and that she will, and her heirs and personal representatives shall, warrant and defend the timber on the above-described premises against the lawful claims
