Beginning at the northeast corner of the southwest quarter of the
northeast quarter, Section 34, Township 2 North, Range 6 E.W.M.;
thence south on subdivision line 660 feet; thence west 288 feet to
the initial point of tract; thence west 22 feet more or less to the
County Road known as Skelton Cut Off Road; thence southerly along
said Skelton Cut Off Road to intersection thereof with the northerly
line of State Highway No. 8; thence easterly along the northerly
line of State Highway No. 8 a distance of 280 feet; thence in a
straight line in a northerly direction 406 feet to the initial point.
SUBJECT to easement for road purposes 20 feet in width.
