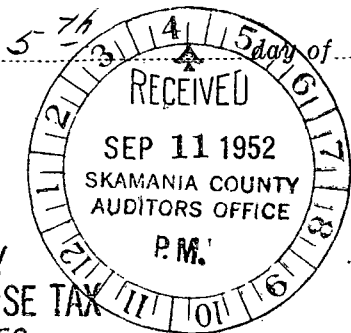
the following described Real Estate, situated in the County of Skamania

State of Washington: Commencing at a point in the center of Kanaka Creek marked by a one inch iron pipe driven in the ground 150 feet south of the north line of Lot 1 in Stevenson Park Addition, according to the plat thereof on file and of record in the office of the Auditor of Skamania County, Washington; thence southeasterly down Kanaka Creek 300 feet; more or less, to the center of a cross chisled in a very large rock near the side of Kanaka Creek; thence in a northeasterly direction to a point 310 feet south of the north line of said Lot 1 and to the west side of the tract of land sold to George Pratt by E. G. Hamilton; thence north to a point 150 feet south of the north line of said Lot 1; thence west to the point of beginning, containing one and 1/5th acres, more or less, and situated in Section 36, Township 3 North, Range 7 E. W. M.

ALSO a strip of land 50 feet in width adjoining the above tract on the south bounded as follows: Commencing at the cross marking the southwest corner of the above tract; thence northeasterly along the southerly line of said tract 200 feet more or less to a point 300 feet south of the north line of said Lot 1 and 205 feet west of the west line of Strawberry Road as located October 7, 1919, the said point being the northwest corner of that tract of land conveyed by George Pratt to A. A. Disbrow by deed recorded at page 270, Book R of Deeds; thence southwesterly along the west line of the above mentioned Disbrow tract to a point which is 350 feet south of the north line of said Lot 1 and west 185 feet from the west line of said Strawberry Road; thence in a straight line, parallel to the first course of this description to the center of Kanaka Creek; thence northerly along the center of Kanaka Creek to the point of beginning.

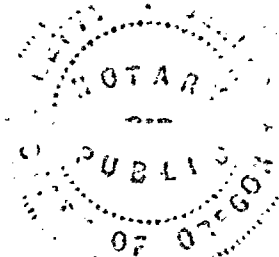

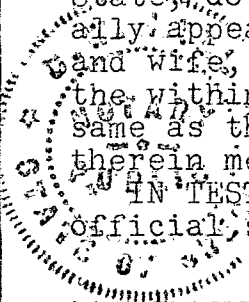
