O R D E R


It appearing to the Commissioner at this time that Application No. 2012 was filed in this office by the Gifford Pinchot National Forest for an easement for a right of way for a road over Lots 4, 5, 6, 11 and 12, section 3, township 4 north, range 9 east, W.M., in Skamania County; that said application was filed in accordance with the Law of 1937 which provides for the granting of rights of way over state lands; and

It further appearing that there is merchantable timber on the area included within the right of way, the said timber having a value of \$3838.00; that the said amount has been deposited in this office by the applicant, and that no good reason exists why this right of way should not be granted, it is therefore

ORDERED and DETERMINED that the plat showing the survey of said right of way, as filed with said application, be and the same is hereby approved as the official plat of said road, and that an easement be and the same is hereby granted to Gifford Pinchot National Forest for a road over and across the following described lands:

Those portions of Lots 4, 5, 6, 11 and 12, section 3, township 4 north, range 9 east, W.M., included within the limits of two strips of land each 66 feet in width and having 33 feet of such width on each side of the following described center lines:

Beginning at a point on the north and south center line of said section 3, which is 2887 feet from the south quarter section corner thereof, running thence N 44° W 192.0 feet, thence along the arc of a curve to the right, whose radius is 1000.0 feet, 130.9 feet, thence N 36° 30' W 548.1 feet to a point designated as point "A", continuing thence N 36° 30' W 10.0 feet, thence along the arc of a curve to the right, whose radius is 1000.0 feet, 235.6 feet, N 23° W 660.4 feet, thence along the arc of a curve to the left, whose radius is 1000.0 feet, 122.2 feet, N 30° W 557.8 feet, thence along the arc of a curve to the right, whose radius is 1000.0 feet, 69.8 feet, N 26° W 844.2 feet, thence along the arc of a curve to the left, whose radius is 500.0 feet, 66.1 feet and N 45° 30' W 340.9 feet to a point on the north line of said section 3



which is 1963.5 feet from the north quarter section corner thereof and having an area of 5.73 acres; also

Beginning at designated point "A" and running thence along the arc of a curve to the left, whose radius is 200 feet, 168.0 feet, N 84° 40' W 1067.0 feet, thence along the arc of a curve to the right, whose radius is 200 feet, 68.6 feet, N 65° W 529.4 feet, thence along the arc of a curve to the left, whose radius is 200 feet, 110.0 feet and S 83° 30' W 145.0 feet to a point on the west line of said section 3 which is 2058.0 feet from the northwest corner thereof and having an area of 3.16 acres.

The above described rights of way have a total area of 8.89 acres according to the plat thereof on file in the office of the Commissioner of Public Lands at Olympia, Washington;

and, it is further

ORDERED and DIRECTED that the sum of \$3838.00, now on deposit in this office to the credit of Gifford Pinchot National Forest covering the value of the timber on the above described right of way, be turned over to the State Treasurer for credit to the Permanent School Fund.
