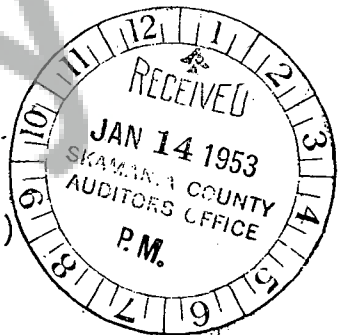

GRANT OF EASEMENT

The Grantors, O. H. RICHTER and Winona E. RICHTER, the wife of said O. H. Richter, of 1013 South Gold Street, Centralia, Washington, for and in consideration of Ten Dollars (\$10) and other good and valuable consideration in hand paid, convey and warrant to HARBOR PLYWOOD CORPORATION, a Delaware corporation, with offices at Aberdeen, Washington, the assignable and unlimited right, without charge or expense to Harbor, except the maintenance expenses fairly attributable to Harbor's use thereof, to service, to repair, to renew, to replace and to use for all the usual and customary purposes of private truck logging roads all roads which may exist as of the date of delivery of this instrument and all roads which hereafter may be constructed over, upon, across or within the following described real estate:

The Southeast Quarter of the Northeast Quarter ( $SE\frac{1}{4}$  of  $NE\frac{1}{4}$ ); the North Half of the Southeast Quarter ( $N\frac{1}{2}$  of  $SE\frac{1}{4}$ ) and the Southeast Quarter of the Southeast Quarter ( $SE\frac{1}{4}$  of  $SE\frac{1}{4}$ ) of Section Eighteen (18), in Township Seven (7) North, Range Six (6) East of the Willamette Meridian,



situated in the County of Skamania, State of Washington.

Together with the right to construct, to service, to repair, to renew, to replace and to use for all the usual and customary purposes of private truck logging roads, all such road extensions as Harbor, in its discretion, may find it necessary or convenient to construct over, across, upon and within the premises described above, for the purpose of reaching and removing timber which Harbor now may have the right to cut or which hereafter it may acquire the right to cut.

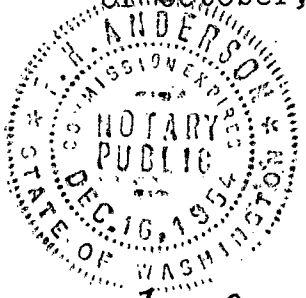
