The grantor hereby covenants with Shepard & Morse Lumber

Company, its successors and assigns, that he is the lawful owner of the above described premises and of the timber thereon, that the same are free from all encumbrances, and that he will and his heirs and personal representatives shall warrant and defend the timber on the above described premises against the lawful claims and demands of all persons whomsoever during the period terminating two years from the date of this deed.


