Skamania County, State of Washington.

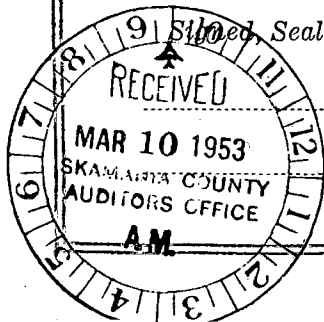

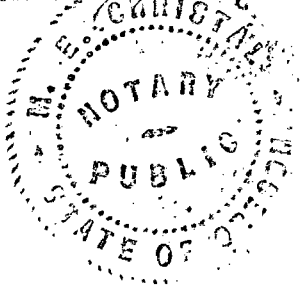
