- (a) Lots 31, 32, and 33 in Madrona Addition to King County and unrecorded plat, said property being bounded on the East by 42nd Avenue South, on the South by Star Lake Road and on the North and West by South 275th Place, being a portion of Section 34, Township 22 North, Range 4, E.W.M.
- (b) Commencing at the NW corner of Section 9, Township 1 N, Range 5 E, E.W.M.; thence South along Section line 40 rods; thence East 80 rods to the East line of the NW 1/4 of the NW 1/4 of said Section 9; thence North 40 rods; thence West 80 rods to the place of beginning, excepting therefrom 3 contiguous parcels of land conveyed to William K.
