

## QUIT CLAIM DEED

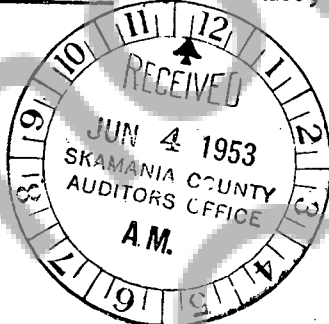
