

WARRANTY DEED

THE GRANTOR, Moffetts Hot Springs Company, a Washington corporation, for and in consideration of the sum of Ten (\$10.00) Dollars, does hereby convey and warrant unto Ray E. Ziegler and Gladys Ziegler, husband and wife, grantees, the following described real property situated in the County of Skamania, State of Washington, to-wit:

A tract of land located in Section 16, Township 2 North, Range 7 East of the Willamette Meridian and being a portion of the

Bishop & Chenoweth Donation Land Claims

Beginning at the Southeast corner of the said Section 16; thence North along the East line of said Section 16, Thirteen Hundred Twenty (1320) feet, more or less to the northeast Hundred Twenty (1320) feet, more or less to the northeast corner of the southeast quarter of the southeast quarter of the said Section 16, said point being on the north line of the Chenoweth D.L.C.; thence west along said north line of the Chenoweth D.L.C. 2904 feet, more or less to the intersection with the East line of the Bishop D.L.C.; thence North along the east line of the Bishop D.L.C. to the Northeast corner thereof; thence west along the north line of the Bishop D.L.C. to intersection with the easterly line of the tract of land acquired by the United States of America for the Bonneville Power transmission line; thence South 28°25' West following the easterly line of the said power line tract to intersection with the east line of that certain County road formerly designated as the Evergreen Highway; thence in a southerly direction following the east line of the said county road to the south line of said Section 16; thence east along the south line of the said Section 16 to the point of beginning.

Mansfield by deeds dated March 11, 1938, June 5, 1947, and February 20, 1948, and recorded respectively at race 8 of Book 27 of deeds and at pages 596 and 636 of Book 31 of deeds a distance of 271.34 feet to the Northwest corner of Lot 5 of Block 18 of the unrecorded plat of the Town of North Bonneville; thence southerly along the west line of Lot 5 of the said Block 18 as designated aforesaid in deed dated June 5, 1947, and along the west line of Lots 18 and 5 of Block

Cole dated April 3, 1950, recorded at page 46 of book 33 of

AND EXCEPTING therefrom that tract of land conveyed to William Bishop by deed dated October 29, 1921 and recorded at page 405

of Book "S" of deeds.

AND EXCEPTING therefrom that tract of land conveyed to C. C. Powers and Frank Daubenspeck by deed dated October 9, 1920, and recorded at page 256 of Book "V" of deeds.

This deed is given in consummation of a contract between Moffetts Hot Springs Company as vendor, and Ray E. Ziegler as Vendee, which contract is dated March 1, 1948, and is subject to all liens, taxes and assessments and other obligations against the property created subsequent to said date by, through or under the grantees because of their possessory rights under the conditional sales contract.
