

STATE OF OREGON - CONT'D.

Wasco County

Assignment of Permit dated September 10, 1958, from Northwest Natural Gas Company, an Oregon corporation, conveying, assigning and transferring into Pacific Northwest Pipeline Corporation, all of its rights, title and interest in and to that certain permit to install upon The Dalles Bridge, and along the right-of-way of The Dalles Bridge approach roads, a pipeline for the purpose of conveying natural gas to The Dalles Natural Gas Company, in Wasco County, Oregon. (Line 507-42, R/W 7-33-001)

Franchise dated October 1, 1958, from the Wasco County Court, Wasco County, Oregon, granting permission to construct, operate and maintain a pipeline for the transmission of natural gas from The Dalles Bridge and along the approaches thereto.

STATE OF UTAH

Daggett County

Decision dated December 23, 1957, from Ernest E. House, Manager, U. S. Department of the Interior, Bureau of Land Management, Salt Lake City, Utah, granting permission to cross certain Federal Lands along the route of the pipeline in Daggett County, Utah. (Line 101 & 301, Utah Serial No. 15664)

DUTCH JOHN SALES METER STATION SITE: Decision dated September 15, 1958, from Ernest E. House, Manager, U. S. Department of the Interior, Bureau of Land Management, Salt Lake City, Utah, granting permission to construct a Dutch John Sales Meter Station in Daggett County, Utah, being a tract of land out of the property of the United States of America. A tract of land out of the SW $\frac{1}{4}$ of Section 1, T-2-N, R-22-E, Salt Lake Meridian, Daggett County, Utah, being more particularly described as follows:

COMMENCING at the common corner between Sections 1 & 2, T-2-N, R-22-E and Sections 35 & 36, T-3-N, R-22-E, Salt Lake Meridian, Daggett County, Utah, thence in a southerly direction along the west line of said Section 1, 3616 feet to the point of intersection with the company's 26" Main Transmission Line; thence, S 67° 22' E - 1504 feet along said 26" Main Transmission Line to a point on a westerly line of the herein described tract of land for the point of beginning:

THENCE, S 22° 38' W, 90 feet to a 2-inch hub set for a corner;

THENCE, S 67° 22' E, 50 feet to a 2-inch hub set for a corner;

THENCE, N 22° 38' E, 100 feet to a 2-inch hub set for a corner;

THENCE, N 67° 22' W, 50 feet to a 2-inch hub set for a corner;

THENCE, S 22° 38' W, 10 feet to the point of beginning, containing 0.11 acres of land more or less, (Utah Serial No. 029274)
