

7. Right of Way Contract dated January 17, 1956, between Norman O. Bain and Pacific Northwest Pipeline Corporation, recorded in Book 3545, Page 100, of the records of King County, Washington, save and except the following described property:

A pipeline right of way across a portion of Lot 7 in Section 9, T-22-N, R-6-E of the Willamette Meridian, King County, Washington, said right of way being 50 feet in width measured 25 feet to either side of a line as actually surveyed and as hereinafter described.

Beginning at a point on the west line of Lot 7 in Section 9, T-22-N, R-6-E of the Willamette Meridian, King County, Washington, from which the SE corner of the SW $\frac{1}{4}$ of the SW $\frac{1}{4}$ of said Section 9 bears S 53° 01' W - 357 feet, S 38° 57' W - 40 feet, S 24° 53' W - 797 feet, S 32° 23' W - 1914 feet and in an easterly direction 380 feet to said corner:

8. Right of Way Contract dated May 11, 1956, between Agnes H. Johnson, et al, and Pacific Northwest Pipeline Corporation, recorded in Book 3579, Page 100 of the records of King County, Washington, save and except the following described property:

The W $\frac{1}{2}$ of the N $\frac{1}{2}$ of the SW $\frac{1}{4}$ of the SE $\frac{1}{4}$ of Section 22, T-24-N, R-6-E, Willamette Meridian.

9. Right of Way Contract dated November 22, 1955, between H. Kenneth McCollough, et ux, and Pacific Northwest Pipeline Corporation, recorded in Book 97, Page 140, of the records of Kittitas County, Washington, save and except the following described property:

A pipeline right of way across a portion of the SE $\frac{1}{4}$ of the NW $\frac{1}{4}$ and the SW $\frac{1}{4}$ of the NE $\frac{1}{4}$ of Section 8, T-17-N, R-19-E, Willamette Meridian, Kittitas County, Washington, said right of way being 75.00 feet in width measured 37.5 feet to either side of a line as actually surveyed and as hereinafter described.

Beginning at a point on the south line of subject property from which the NW corner of the SE $\frac{1}{4}$ of said Section 8, T-17-N, R-19-E, Willamette Meridian, Kittitas County, Washington, bears S 81° 28' 40" E, 191.07 feet;
