

THENCE, N 29° 05' E, 1518 feet to a point on the north line of the said SW $\frac{1}{4}$  of the NE $\frac{1}{4}$  of said Section 8, from which the SW corner of the E $\frac{1}{2}$  of the NW $\frac{1}{4}$  of the NE $\frac{1}{4}$  of said Section 8 bears in an easterly direction 96 feet.

The herein described right of way contains 2.61 acres of land, more or less.

10. Right of Way Contract dated November 28, 1955, between Stanley Waltrip, et ux, and Pacific Northwest Pipeline Corporation, recorded in Book 379, Page 364, records of Lewis County, Washington, insofar as the same covers a tract of land described as follows:

The NW $\frac{1}{4}$  of the NE $\frac{1}{4}$  and the SW $\frac{1}{4}$  of the NE $\frac{1}{4}$  of Section 25, T-14-N, R-2-W, except that part of the said SW $\frac{1}{4}$  of the NE $\frac{1}{4}$  lying South of the county road.

11. Right of Way Contracts dated December 17, 1955 and April 24, 1956, recorded in Book 1106, Page 575 and Book 1114, Page 519, respectively, in the records of Pierce County, Washington, between John P. Gallagher, et al, and Pacific Northwest Pipeline Corporation, insofar as the same covers a tract of land described as follows:

The West 150 feet of the North 204 feet of the following:  
NW $\frac{1}{4}$  of NE $\frac{1}{4}$  of Section 16, T-19-N, R-4-E of the W.M.,

EXCEPT, from said North 204 feet the North 30 feet thereof, and from the said West 150 feet, the West 30 feet thereof, for roads.

12. Right of Way Contract dated December 6, 1955, between George M. Trump, et ux, and Pacific Northwest Pipeline Corporation, recorded in Book 1106, Page 581, of the records of Pierce County Washington, save and except the following described property:

A pipeline right of way across a portion of Lots 196 and 221 of the Half Dollar Berry Tracts in Section 9, T-19-N, R-4-E of the Willamette Meridian, Pierce County, Washington, said right of way being 50 feet in width measured 25 feet to either side of a line as actually surveyed and as hereinafter described.

Beginning at a point on the west line of Lot 221 of the Half Dollar Berry Tracts in Section 9, T-19-N, R-4-E of the Willamette Meridian, Pierce County, Washington, from which a concrete monument at the intersection of the proposed roads between Lots 188, 189, 196 and 197 of the said Half Dollar Berry Tracts bears S 25° 32' W - 70 feet, more or less; thence in a northerly direction 496 feet:

THENCE, N 25° 32' E at 100 feet more or less cross the division line between said Lots 221 and 196, continuing for a total distance of 450 feet, more or less, to a point on the north line of said Lot 196, from which the same said concrete monument at said intersection bears N 25° 32' E - 33 feet, more or less; thence in a westerly direction 235.5 feet.
