

13. Right of Way Contracts dated December 1, 1955, between Raymond W. Gogan, et al, and Pacific Northwest Pipeline Corporation, recorded in Book 1106, Page 607, and April 6, 1956 between Eddie E. Felt, et ux, and Pacific Northwest Pipeline Corporation, recorded in Book 1110, Page 847, both recorded in the records of Pierce County, Washington.

14. Right of Way Contract dated January 10, 1956, between Jack G. Magee, et ux, and Pacific Northwest Pipeline Corporation, recorded in Book 1105, Page 781, of the records of Pierce County, Washington, save and except the following described property:

A right of way across the $SE\frac{1}{4}$ of the $NW\frac{1}{4}$ of the $NE\frac{1}{4}$ of Section 30, T-20-N, R-5-E, Willamette Meridian, Pierce County, Washington, said right of way being 100 feet in width measured 20 feet to the left (Northwesterly) and 80 feet to the right (Southeasterly) as actually surveyed and as hereinafter described.
