BIG PINEY OIL & URANIUM COMPANY REGULATOR AND METER STATION SITE: Tract 1: Federal Oil and Gas Lease dated September 1, 1950, from the Bureau of Land Management, Land Office, Cheyenne, Wyoming and being more particularly described as follows:

Commencing at the common corner between Sections 2, 3, 10, and 11, T. 29 N., R. 113 W., 6th Principal Meridian, from which the SW corner of said tract bears S 88° 05' W, 244 feet, N 23° 35' W, 2038 feet, S 67° 25' W, 5 feet; Thence, N 22° 35' W, 25 feet to a corner; Thence, N 67° 25' E, 50 feet to a corner; Thence S 22° 35' E, 25 feet to a corner; Thence S 67° 25' W, 50 feet to the point of beginning and containing 0.03 acres of land.
