
## TRANSMISSION LINE EASEMENT

The GRANTOR, herein so styled whether one or more, CARL KROHN and ESTHER KROHN, husband and wife at the time of acquiring title and ever since,

That portion of Government Lot 2 of Section 7, Township 3 North, Range 10 East of the Willamette Meridian, Skamania County, Washington, which lies within a strip of land 300 feet in width, the boundaries of said strip lying 212.5 feet distant northerly from and 87.5 feet distant southerly from and parallel to the survey line of the McNary-Ross transmission line as now located and staked on the ground over, across, upon, and/or adjacent to the above described property, said survey line being particularly described as follows:

Beginning at survey station 6828 + 30.0 a point on the North-South quarter section line of Section 7, Township 3 North, Range 10 East, Willamette Meridian, said point being N. 2° 03' 40" E. a distance of 2444.7 feet from the quarter section corner on the south line of said Section 7; thence N. 83° 39' 00" W. a distance of 2412.0 feet to survey station 6852 + 42.0 a point on the west line of said Section 7, said point being N. 1° 45! 20" E. a distance of 2611.8 feet from the south-west corner of said Section 7.

Under the terms of this easement, the right to cut danger trees is limited to a strip of land 75 feet in width on the north side of and beyond the outside limits of the right-of-way.





together with the right to clear said parcel of land and keep the same clear of all brush, timber, structures, and fire hazards, provided however, the words "fire hazards" shall not be interpreted to include growing crops; and also the present and future right to top, limb, fell, and remove all growing trees, dead trees or snags (collectively called "danger trees") located on Grantor's land adjacent to said parcel of land, which could fall upon or against said transmission and signal line facilities.

TO HAVE AND TO HOID said easement and rights unto the UNITED STATES OF AMERICA and its assigns, forever.

The Grantor covenants to and with the UNITED STATES OF AMERICA and its assigns that the title to all brush and timber cut and removed from said parcel of land and also all growing trees, dead trees or snags (collectively called "danger trees") cut and removed from Grantor's land adjacent to said parcel of land, is and shall be vested in the UNITED STATES OF AMERICA and its assigns and that the consideration paid for conveying said easement and rights herein described is accepted as full compensation for all damages incidental to the exercise of any of said rights.

The Grantor also covenants to and with the UNITED STATES OF AMERICA that Grantor is lawfully seized and possessed of the lands aforesaid; has a good and lawful right and power to sell and convey same; that same are free and clear of encumbrances, except as above indicated; and that Grantor will forever warrant and defend the title to said easement and the quiet possession thereof against the lawful claims and demands of all persons whomsoever.
