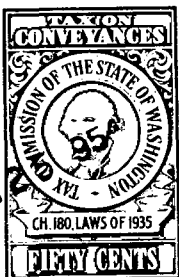

ALSO: the West one-half of the Southeast quarter of Section 30, Township 3 North, Range 8, East of the Willamette Meridian.

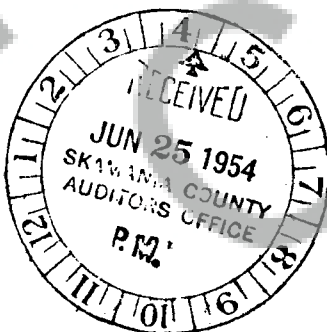
