## A-13—Yale Hydroelectric Generating Plant

All those parts of Lot 3 in Section 25 and of Lot 4 in Section 35 lying northerly of the contour line, elevation 490 feet above mean sea level, United States Coast and Geodetic Survey datum; and the right temporarily, from time to time, to overflow all or any part of said Lot 3 which lies southerly of the contour line at said 490 feet elevation and northerly of a line described as beginning at a point on the west line of said Lot 3 which is 583.01 feet north of the southwest corner of said Section 25; thence north 72° 12′ 45″ east 935.49 feet; thence north 46° 09′ 50″ west 210 feet; thence north 44° 52′ 20″ east 115.37 feet; and thence south 81° 42′ 30″ east 501.44 feet to a point on the east line of said Lot 3 which is 1020 feet north of the southeast corner of said Lot 3, and similarly at such times to overflow all or any part of said Lot 4 of Section 35 which lies southerly of said 490-foot contour line and northerly of a line described as beginning at a point on the west line of said Lot 4 which is 1044.29 feet north of the southwest corner of said Lot 4; thence north 66° 37′ 20″ east 760 feet, more or less, to a point on the north line of said Lot 4, which is 614.68 feet west of the northeast corner of said Lot 4, save and except, however, so much of said area in Lot 3 in Section 25 and Lot 4 in Section 35 lying southerly of said 490-foot contour line as may presently be used for roadway purposes.
