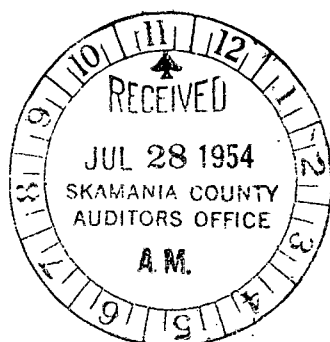

QUITCLAIM DEED

Fandrei and Evelyn N. Fandrei, husband and wife, the following described real estate, situate in the county of Skamania, State of Washington:

Ten acres of land being part of the west half of the southwest quarter of Section 35, Township 3 North, Range 7 E.W.M. used by Charles LeBong as an orchard and fenced with a wire fence as described in deed from E. P. Ash and Nellie E. Ash, his wife, recorded in Book L of Deeds page 350, Records of the Auditor of said Skamania County, Washington. The said property having been surveyed by H. S. Hall December 22, 1924, the field notes of said survey being as follows, to-wit:

Beginning at a point 114 feet west of the southeast corner of the northwest quarter of the southwest quarter of Section 35, Township 3 North, Range 7 E. W. M., thence north $02^{\circ} 26'$ east 147 feet, thence north $70^{\circ} 11'$ west 266 feet, thence north $69^{\circ} 19'$ west 300 feet, thence north $70^{\circ} 09'$ west 500 feet, thence south $20^{\circ} 59'$ west 347 feet, thence south $58^{\circ} 01'$ east 156 feet, thence south $59^{\circ} 41'$ east 430 feet, thence south $77^{\circ} 05'$ east 254 feet, thence north $67^{\circ} 25'$ east 294 feet, thence north 79° east 100 feet, thence north $24^{\circ} 05'$ west 56 feet to the place of beginning, containing 9.34 acres.






