SUPPLEMENTAL CHATTEL MORTGAGE AND REAL PROPERTY MORTGAGE

State of Washington, City of Stevenson, County of Skamania

hereinafter called Mortgagor, and Small Business Administration, an agency of the United States created by an Act of Congress and having an Office for the transaction of business in the City of Seattle
State of Washington, hereinafter called Mortgagee:

WITNESSETH:

Whereas, Mortgagor executed in favor of Mortgagee, a Mortgage, herein called Original Mortgage, encumbering certain personal property described therein, dated March 1, 1958, to secure a Note dated March 1, 1958, in the amount of TWO HUNDRED TWENTY-FIVE THOUSAND AND NO/100 Dollars (\$ 225,000.00), said Mortgage being filed under File No. 53423 in Volume 34 of Mortgages, page 143, records of Skamania County, Washington, and filed as a Chattel Mortgage under Vault File No. 53424 in same County.

Whereas, in and by the terms of the said Original Mortgage, the Mortgagor agreed and covenanted that it was the intention of said Original Mortgage to include and encumber as security for the loan all other personal property which was thereafter acquired by Mortgagor for use in its business, and that Mortgagor would execute a further Mortgage or Mortgages in terms similar to the Original Mortgage with the intent and to the end that all such personal property would be effectually held as security for the payment of the mortgage debt; and

Whereas, the Mortgagor has since acquired and now owns the items of personal property described in the Detailed Property Schedule attached hereto and by this reference incorporated herein; and this Supplemental Mortgage is made to comply with the covenants of the Original Mortgage;

Now, Therefore, in consideration of the foregoing and of Mortgagor's obligation so to do, and as security for the indebtedness described in said Original Mortgage, and Note, Mortgagor does hereby mortgage unto Mortgagee, its successors and assigns, real and the personal property presently situated and located in the County of Skamania, State of Washington, at the following address:

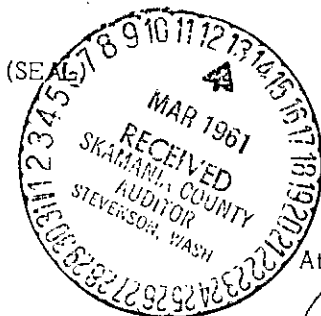
