OPTION TO PURCHASE

Any land deeded to Mr. Schanz under this option shall be conveyed to him free and clear of any encumbrances whatsoever.

Mr. F. L. Schanz shall have the right to go on the lands which are being purchased from him by the Gould Timber Company at any and all reasonable times; providing, he does not interfere with the operations of the Gould Timber Company, to see if the terms of the contract of sale between F. L. Schanz and Gould Timber Company, dated February 6, 1936, are being performed.
