3. That maturity and time for payment of the note and marking shall be and is hereby extended to the 25th
day of October , 1968.
4. Parties of the second part agree that they will pay pricipal and interest of the said indebtedness at the time and in accordance with the terms hereof and of the said promise and mortgage as herein modified.
5. In event of any default in the payment of any installment of the indebtedness or the breach of any covenan contained in the note, renewal note, mortgage or this agreement, it shall be optional for the party of the first part to declare the principal sum immediately due and payable without notice.
6. Parties of the second part agree to pay the party of the first part \$ 54.54 monthly beginning
10-25-61 & on the 25th day of each month hereafter during the life of the loan to be applied
the indebtedness.
7. The party of the first part agrees to and by these presents does extend to the parties of the second part the
maturity and time for payment of said note and mortgage to the date hereinbefore stipulated.
