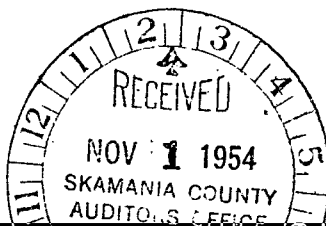

JUDGMENT GRANTING AN ABSOLUTE DIVORCE

This cause having come on regularly for trial this 22nd day of December, 1952 before the Honorable Hugh Todd one of the Judges of the above entitled Court; the plaintiff appearing in person and being represented by Patricia J. Shanahan and the defendant appearing in person and being represented by W. L. Gibbon; the cause proceeding to trial upon the introduction of evidence on behalf of the plaintiff until the close thereof; the Court having heard and considered the same, and being satisfied of the Court's jurisdiction of the parties to and the subject matter of the action; the Court having entered its Findings of Fact and Conclusions of Law herein, now, therefore,

IT IS HEREBY ORDERED, ADJUDGED AND DECREED that the plaintiff be and she hereby is awarded a full, complete and final divorce from the defendant.

IT IS FURTHER ORDERED, ADJUDGED AND DECREED that the defendant pay to the plaintiff the sum of Eighteen Hundred Seventy Five Dollars (\$1875.00) in full and complete settlement of the property rights of the parties. That said sum shall be paid as follows: \$375.00 on the 22nd day of December, 1952 and the balance of \$1500.00 in monthly payments of \$125.00 commencing on the 1st day of January, 1953. That said settlement amount shall constitute a specific lien on the following described real property located in Skamania County:

TRACT "A": The SW $\frac{1}{4}$ of Section 9, Twp. 1 North, Range 5 E. W. M., and the SE $\frac{1}{4}$ of the SE $\frac{1}{4}$ of Section 8, Twp. 1 N. Range 5 E. W. M., excepting the following:

- (1) Ten acres off the east end of the N $\frac{1}{2}$ of the SW $\frac{1}{4}$ of Sec. 9 aforesaid;
- (2) One acre, commencing at the NW corner of the SW $\frac{1}{4}$ of Se. 9; thence South 2 rods to north line of Cape Horn and Mt. Zion Road, thence along the northerly line of said road to the NE corner of the NW $\frac{1}{4}$ of Sec. 9; thence west to the place of beginning;
- (3) Thirty Acres more or less conveyed to Henry J. Biddle by deed recorded at page 227 Book "N" of Deeds, records of Skamania County, and easement for road described in said deed;
- (4) Spring and easement described in deed to Fred and Alfred Cocher recorded at page 326 Book "I" of Deeds records of Skamania County;
- (5) Easement conveyed to Northwestern Electric Company.

TRACT "B": Beginning at a point 40 rods South of the Northwest corner of Section 9, township 1 North, Range 5, East of the Willamette Meridian, and running thence South 122 rods, more or less, to the North line of the old Cape-Horn-Mount Zion Road; thence Northeasterly and following the North line of said road to a point on the South line of the Northwest quarter of said section; thence East on said line to the Southeast corner of said Northwest quarter, thence along the East line of said Northwest quarter, 120 rods, more or less, to the Southeast corner of the North Half of the Northeast quarter of the Northwest quarter of said section 9, thence West to a point that is 40 rods South of the Northeast corner of NW $\frac{1}{4}$ of the Northwest quarter of said section, thence West 80 rods, more or less, to the place of beginning.

IT IS FURTHER ORDERED, ADJUDGED AND DECREED that all payments referred to hereinabove with the exception of the initial payment of \$375.00, shall be made into the Registry of the Court.

IT IS FURTHER ORDERED, ADJUDGED AND DECREED that the plaintiff be and hereby is granted the return of the name Alta Crossen.
