JUDGMENT GRANTING AN AB-SOLUTE DIVORCE

This cause having come on regularly for trial this 22nd day of December, 1952 before the Honorable Hugh Todd one of the Judges of the above entitled Court; the plaintiff appearing in person and bein, represented by Patricia J. Shananan and the defendant appearing in person and being represented by V. L. Gibthe cause proceeding to trial upon the introduction of evidence on behalf of the plaintiff until the close thereof; the Court having heard and considered the same, and being satisfied of the Court's jurisdiction of the parties to and the subject matter of the action; the Court having entered its Findings of Fact and Conclusions of Law herein, now, therefore,

IT ID HEREBY ORDERED, ADJUDGED AND DECREED that the plaintiff be and she hereby is awarded a full, complete and final divorce from the defendant.

IT IS FURTHER ORDERED, ADJUDGED AND DECREED that the defendent pay to the plaintiff the sum of Lighteen Hundred Seventy Five Dollars (\$1375.00) in full and complete settlement of the property rights of the parties.
